Note from the Tabulation Director: North Carolina (N 529), Georgia (O 826), Duke (H 306), and Duke (A 307) would have all earned bids to the National Tournament if not for the two-team per program cap on postseason bids. Duke received two bids from the "Greenville II" Tournament because that tournament was assigned PPP credit for Duke's A & B teams. (All teams that competed in the prior year's postseason carry PPP credit.) Because Georgia and North Carolina only had one team each with PPP credit, the first bid for both came from The Haynsworth Sinkler Boyd, P.A. regional. By rule, the second bid for both came from the Greenville II Tournament (even though their second teams in the HSB Tournament had better records than their Greenville II counterparts.) Although the rules dictate which bids are "live" the institution gets to select which students/teams use the postseason bid.
