Developing AMTA: Building a National Network

AMTA's Development Committee has been hard at work building partnerships with new tournament hosts, reconnecting with former competitors and alumni, and creating relationships with other organizations.

School Sponsorships

Every spring, AMTA holds over thirty tournaments between Regionals, ORCS, and Nationals. These tournaments take place from coast to coast, and each tournament hosts over two hundred competitors, not to mention coaches, judges, and spectators. Needless to say, this is a tremendous undertaking, and none of our tournaments would be possible, let alone successful, without our hosts, AMTA representatives, volunteer judges, or countless other partners who donate their time and energy.

This year, AMTA has added more schools to its list of sponsors—Quinnipiac Law School, Concordia University College of Law, University of Pittsburgh School of Law, Baylor Law School, Widener University Delaware School of Law, University of South Carolina School of Law. Finally, the Charleston School of Law graciously sponsored the National Championship Tournament hosted by Furman University.
